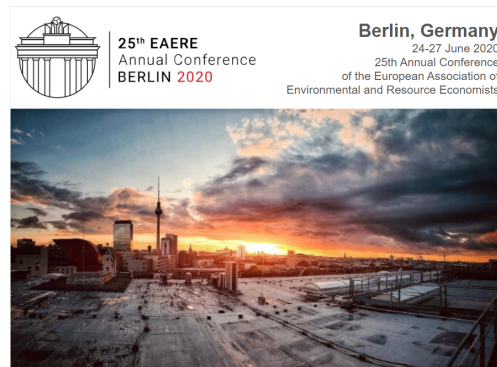
EAERE 2020 Annual Conference: open calls for papers and for policy & thematic sessions

The 25th UNFCCC Conference of the Parties will take place on December 2-13 in Madrid, Spain. The conference aims at taking further, crucial steps in the UN climate change negotiations. A key objective is to complete several matters for the operationalization of the Paris Climate Change Agreement. The conference also aims to create ambition in view of 2020, by when countries have committed to submit updated national climate action plans. UN Climate Action Yearbook and Climate Actions Pathways

The Yearbook of Global Climate Action 2019 takes stock, highlighting climate action success stories and the need for conditions leading to stepped up climate action, while the Climate Action Pathways suggest transformational actions and milestones towards neutrality in key areas such as energy, industry, transport, human settlements, water, land use, and resilience to the inevitable effects of climate change. The documents were developed by the coalitions and initiatives of the Marrakech Partnership for Global Climate Action, under the leadership of the High-Level Champions. Both the Yearbook and the Pathway documents are comprehensive references for negotiators as they prepare for the UN Climate Conference (COP 25) in Madrid in December, they will be presented at an event on December 4 and integrated throughout the events of the Marrakech Partnership in Madrid.

UNEP Emissions Gap Report 2019

The tenth edition of the United Nations Environment Programme (UNEP) Emissions Gap Report provides the latest assessment of scientific studies on current and estimated future greenhouse gas (GHG) emissions and compares these with the emission levels bearable for the world to progress on a least-cost pathway to achieve the goals of the Paris Agreement. This Report wants to fill in the gap between where we are now in terms of emissions, and where we need to be. Reflecting on the ten-year anniversary, a summary report, entitled Lessons from a decade of emissions gap assessments, was published in September for the Secretary General's Climate Action Summit.

EEA's overview of reported national policies and measures on climate change mitigation in Europe in 2019

In 2019, EU Member States reported a total of 1925 expired, existing and planned policies and measures. This represents an increase in the number of policies and measures reported by Member States, that partially can be explained by the preparation of the National Energy and Climate Plans and the new interventions that they include. However, despite modest improvement, quantitative evidence on the effectiveness and costs of these measures remains insufficiently reported.

CEPS Policy Brief - Circular Economy For Climate Neutrality: Setting the priorities for the EU

This policy brief looks at how circular economy can support EU climate policy, emphasizing that circular economy is more than just another 'product standards' policy. It states that there is a need for a framework to address trade-offs, such as between the circular and the bioeconomy, but also between material efficiency and energy use. A mechanism to steer and monitor progress, for example through targets, is also necessary to increase ambition. The report adds that the new Commission will need to develop and scale up successful products and processes to create opportunities while addressing risks, such as dependency on raw materials.

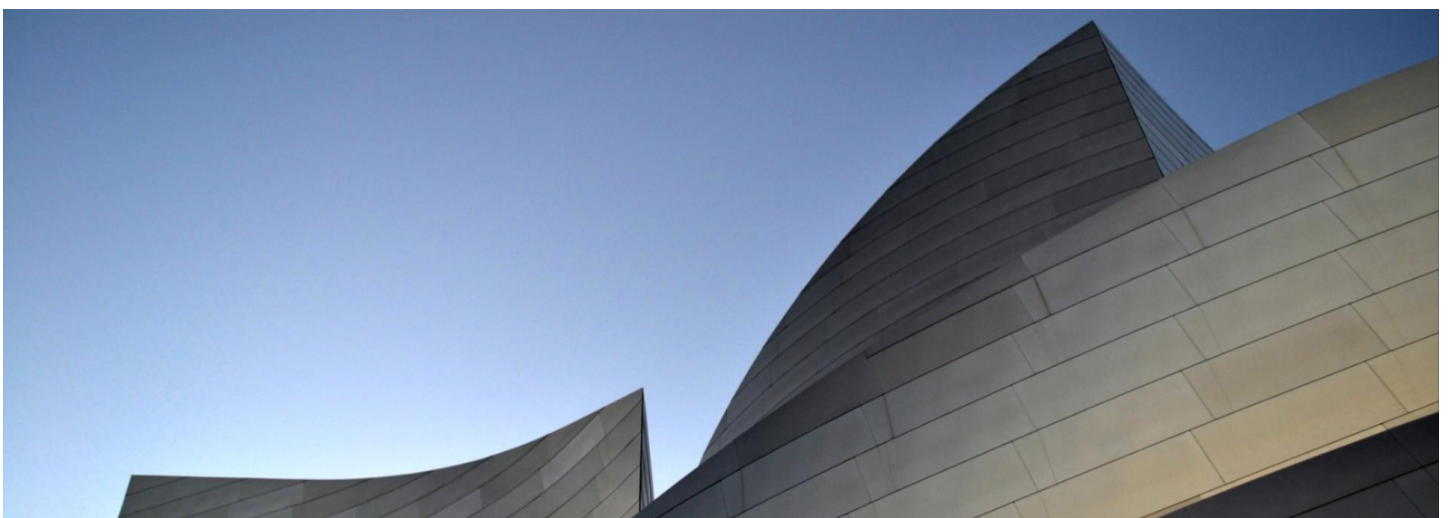
