EAERE Summer School in Resource and Environmental Economics - 2020 edition

The 2020 edition of the EAERE Summer School in Resource and Environmental Economics will focus on **Economic implications of climate change – Integrating the micro and macro dimension in data, modelling and approaches.** This edition is organised by EAERE and the GEMCLIME partners CMCC Foundation and Grantham Research Institute on Climate Change and the Environment at LSE, in cooperation with the Venice International University. The climate crisis is one of the most urgent issues facing the European Union today. The EU has played a leading role in the global climate challenge by committing to reach climate neutrality by 2050 and intends to play a key role as regulator, negotiator and actor in the global climate challenge. While a unilateral European action will not be sufficient to stop global warming, the EU can lead the world in adopting more stringent climate regulations. Through speakers presentations and a roundtable discussion which will open to floor to views from experts and the audience, the panel session will discuss how the EU and other countries can learn from their own experiences to replicate or coordinate climate policies. It seeks to delineate lessons for environmental policy, to identify knowledge gaps for further research, and to contribute towards building a research community on the inequality-environment nexus.

The 2019 Human Development Report – Beyond income, beyond averages, beyond today: Inequalities in human development in the 21st century is the latest in the series of global Human Development Reports published by the United Nations Development Programme (UNDP) since 1990. This edition focuses in particular on inequalities, as in every country still many people have little prospect for a better future. Despite many have managed to escape extreme poverty worldwide, even more do not have the opportunities nor the resources to control their place in society due to different social inequalities such as gender, ethnicity or wealth.

This report presents the first full set of results from the Global Futures project developed by WWF. 
