EAERE's 26th Annual Conference will be hosted in Berlin from Wednesday, June 24 to Saturday, June 26, 2021. The conference is organized by Technische Universität Berlin (TU Berlin) and Humboldt-Universität zu Berlin (HU Berlin). It is supported by the wider Berlin research community in environmental and resource economics, most notably by the German Institute for Economic Research (DIW Berlin), and Mercator Research Institute on Global Commons and Climate Change (MCC). The Editor-in-Chief's duties include assigning incoming submissions to Co-Editors, currently handling over 700 submissions per year. The Editor-in-Chief will work with our excellent team of Co-Editors (currently 27 prominent colleagues active in the journal's field) and will herself/himself handle the editing of a certain number of papers (finding referees, obtaining reports and making final decisions about acceptance or rejection). Q-Open Journal

Developed by Oxford University Press, the European Agricultural and Applied Economics Publications Foundation, and the European Association for Agricultural Economics, Q Open is a new open-access journal, publishing across agricultural, climate, environmental, food, resource, and rural development economics. Q Open's editors are lain Fraser, Erwin Bulte, Vincenzina Caputo, Phoebe Koundouri, and David Lewis, supported by a team of associate editors who handle papers in their speciality, including several specialists in environmental and resource economics. The journal aims to provide a first decision within 4-6 weeks, and authors have the option to share reports from a previous submission. Q Open operates 'sound-science' peer review, where the focus is on scientific rigour, and the decision on acceptance/rejection relies less on the often subjective evaluations of likely impact, novelty, or breadth of interest. 




GGKP Expert Connect

New proposed missions for a greener, healthier and more resilient Europe


