EAERE - Uni Graz Summer School 2021

The summer school on "**Design and evaluation of instrument packages for carbon-neutral development pathways**" discusses the current state of economic modeling to support the design of instruments for reaching carbon-neutrality by 2050, their timing, as well as the (in)effectiveness of policy packages in place. Issues addressed concern how to address multidimensional societal targets, how to build upon the IPCC long term scenario framework in path design, how to incorporate uncertainties in social and technological innovation, how to account for preferences changing over time, how to design the sequencing of instrument packages over time, and how to account for interdependencies across instruments.

RFF-CMCC-NAVIGATE Webinar "Effect of mitigation cost and climate damages on inequalities"

On November 19 2020 at 3:00 pm CET, RFF-CMCC and the NAVIGATE project webinar "*Effect of mitigation cost and climate damages on inequalities*" will take place. What is the prospect for future inequality between countries under climate change? In addition to socioeconomic impacts regarding demography, education and technology progress, climate change will affect future inequality. Analysis of scenarios accounting for these effects of climate change under different emission pathways reveals that climate damage will hit disproportionately poorest countries and mitigation costs will be unevenly distributed among them. Even under low damage estimates, this situation occurs in some scenarios. Thus, mitigation of climate change can be key to limiting future inequality, provided that mitigation costs do not fall on the poorest countries.

Assessment of Green Recovery Plans After COVID-19

In light of the massive economic cost that COVID-19 is going to represent both in terms of GDP and lost jobs in most countries, it will be difficult for the economy to recover immediately. This report assesses two recovery plans that could boost both GDP and protect jobs.
