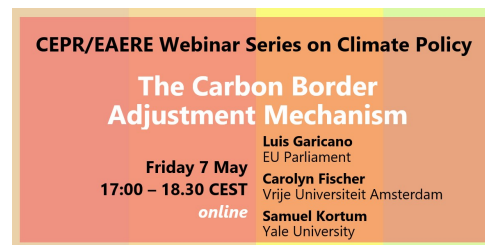

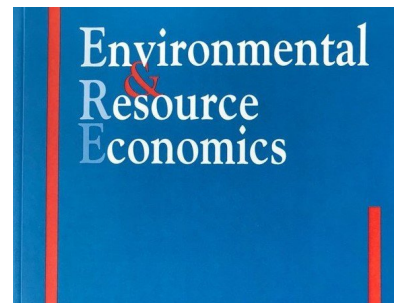

The book, which will contain contributions from experts in these fields, is primarily aimed at scholars who have recently begun doing research in this area (or are contemplating moving in this direction) and look for a comprehensive and rigorous overview of the state-of-the-art in behavioural environmental economics. Several esteemed researchers have already agreed to contribute to the volume. However, editors would like to add a **section on the environment, unexpected shocks (such as natural disasters or a pandemic), and their behavioural consequences**. New contributions or new versions of published works are accepted, as long as they contain new results that were not included in the original publication. Literature reviews are also welcome.

First drafts of the papers should be sent by **July 31, 2021**.
