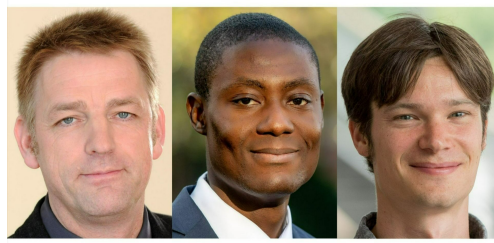

## Endorse the Statement on the EU's legislative proposals on climate change by signing it!

The [Policy Outreach Committee \(POC\)](#) of EAERE prepared a statement on the EU's legislative proposals on climate change that is presented for endorsement to the whole scientific community in Europe and worldwide. The statement aims to draw the attention of policy-makers and public opinion on the implications of the legislative package and on some key challenges that need to be addressed in the future. While the package can be further improved, it takes a step in the right direction if we want to raise the ambition of the European climate policy and achieve climate neutrality by mid-century. A rapid implementation of more ambitious policies is of crucial importance to fulfill our commitments, particularly after COP26. The Statement has currently been officially translated into: Finnish, French, German, Greek, Italian, Polish, Spanish and Swedish.

## 2nd report of the SDSN Senior Working Group on EGD & SDSN Global Climate Hub

The presentation of the 2nd Report of the SDSN Senior Working Group on the European Green Deal, entitled *"Financing the Joint Implementation of Agenda 2030 and the European Green Deal"* took place on Tuesday, May 3rd, during a public debate moderated by the head of the writing team, EAERE President Prof. [Phoebe Koundouri](#), with the participation of, among others, the main authors of the report, Greek government ministers and MEPs. The event, [broadcasted live on YouTube](#), kicked off with high level remarks from keynote speakers including Prof. [Yannis Ioannidis](#), Prof. [Christos Zerefos](#) and Prof. [Jeffrey Sachs](#). On the occasion of the presentation of the report, Prof. Phoebe Koundouri announced the SDSN Global Climate Hub (GCH), which will be co-chaired by her, Prof. Jeffrey Sachs, Prof. Yannis Ioannidis, Prof. Christos Zerefos and Prof. [Andreas Papandreou](#) and will be launched next July during the *"Workshop on Ancient Wisdom for Modern Challenges"* in Athens.

## New paper "Finding the right partners? Examining inequalities in the global investment landscape of hydropower"

This work, published on Global Environmental Change, explores the financial system behind hydropower, investors' behaviour and the optimal allocation of finance to favour the deployment of capital flows. We find that investors are highly localized, with continental players mostly interacting with counterparts in the same area of the world. Powerful exceptions are international organisations and multilateral banks which coinvest across the globe. They also tend to support low-income and fragile countries, meeting their mandate of sustainable development champions. Multilateral banks and international organisations are the most critical actors in enabling public-private co-investments; they activate partnerships with a wider diversity of investors within the network creating

more opportunities for blended finance tools. Our results offer a novel perspective on finance for the energy transition: it challenges the idea that more capital invested is better and calls for a more efficient allocation of the available resources.

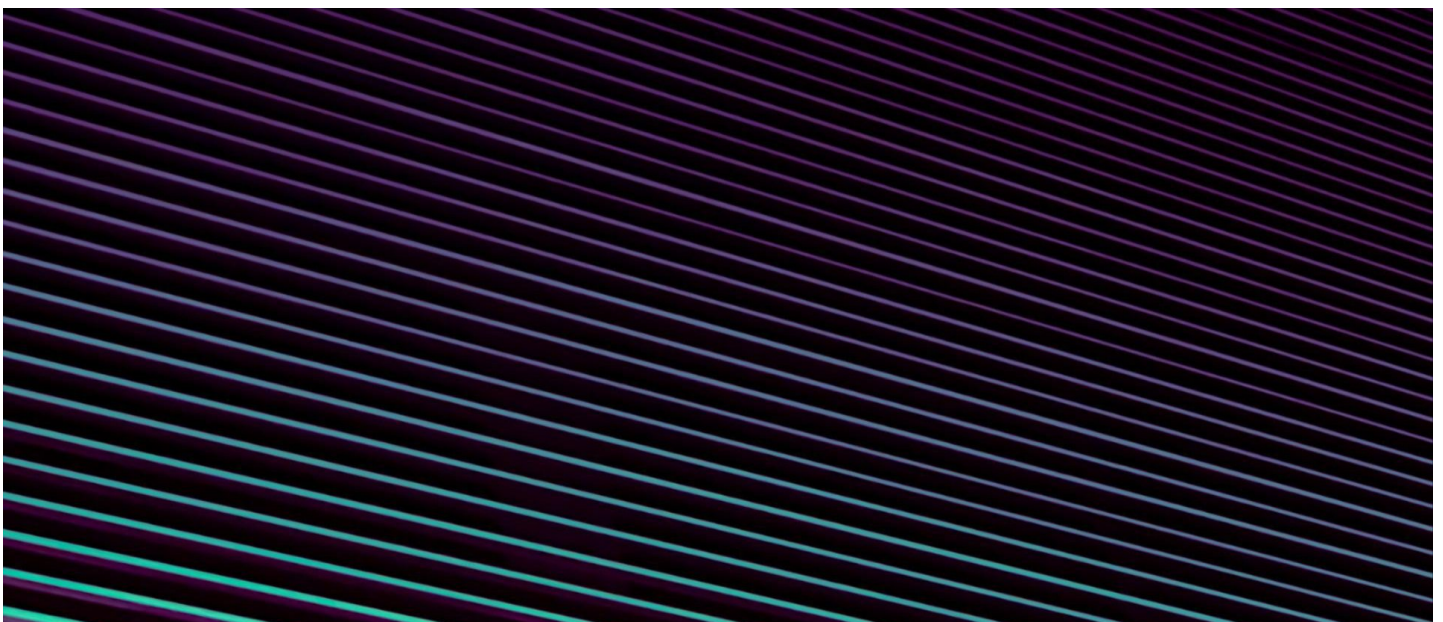

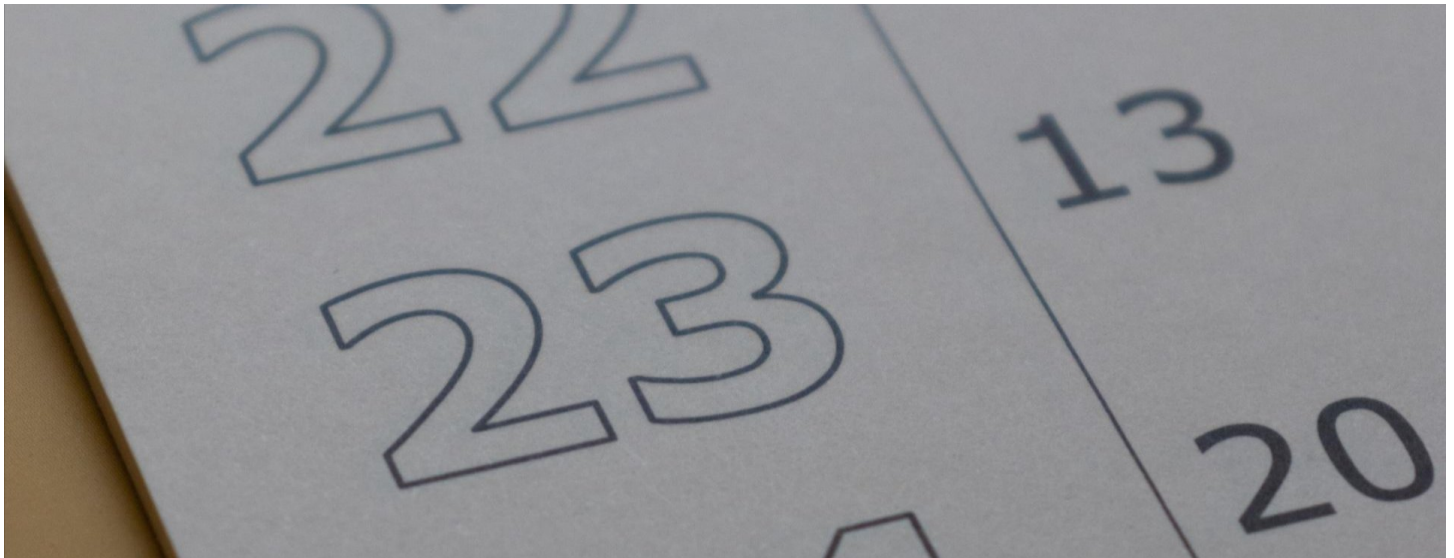
