The World Academy of Art and Science was founded in 1960 on the initiative of Albert Einstein and Robert Oppenheimer. Today the Academy is composed of about 800 Fellows from 90 countries, including scientists, leading artists, politicians, statesmen, heads of research institutes and international organizations, Nobel Prize winners, and business leaders.

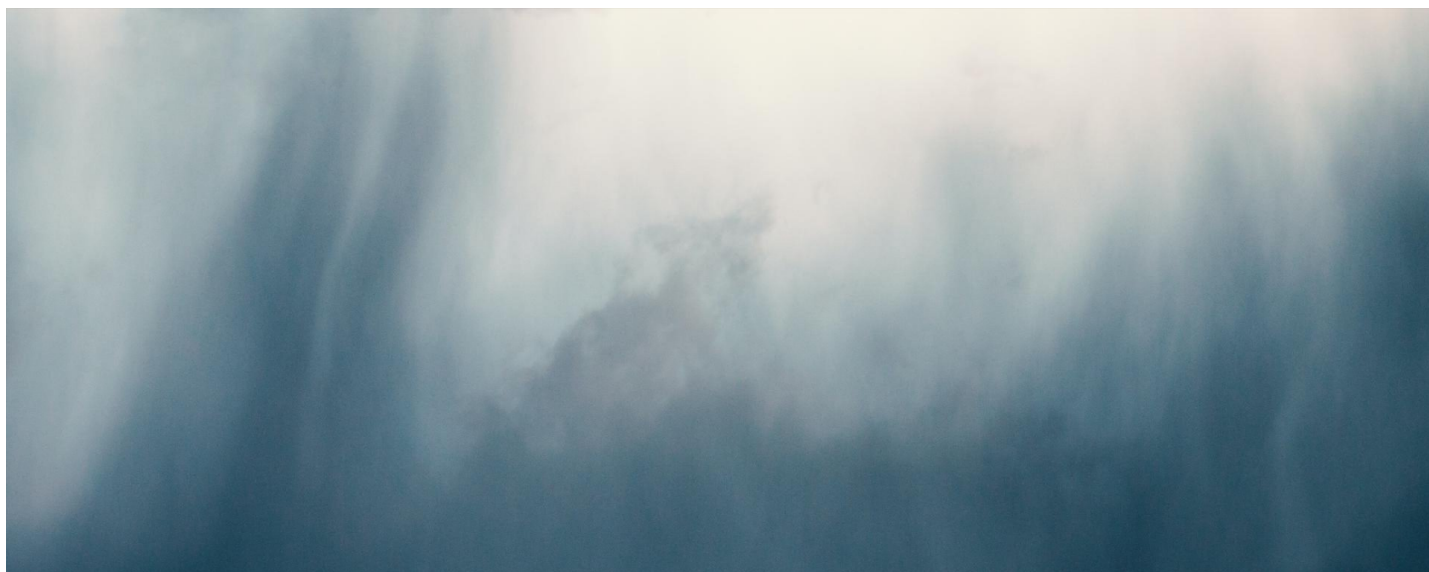
GGKP Expert Connect

EAERE at ECHA: periodical report

Since 2012 EAERE has observer status at meetings of the Socio-Economic Assessment Committee (SEAC) convened at the European Chemicals Agency (ECHA) in Helsinki under REACH (Registration, Evaluation, Authorisation and Restriction of Chemicals). Dr. Mike Holland (Ecometrics Research and Consulting – EMRC, and Imperial College London) and Prof. Roy Brower (University of Waterloo) are the current EAERE delegates. EAERE's position as a stakeholder organisation has developed to provide advice to the REACH process on the application of environmental economics. EAERE representatives do not lobby specifically for adoption or rejection of any proposals made, but provide comment on the science underpinning the arguments made.
