## EAERE 2023: call for Policy and Thematic Sessions - deadline 31 January 2023

There will be two types of pre-organised sessions at EAERE 2023 for which proposals are now invited. (1) **POLICY SESSIONS** aim to advance the use of environmental and resource economics to support policy-making and to provide a forum of exchange between policy-makers and academics. (2) **THEMATIC SESSIONS** aim to highlight current research on a subject in environmental and resource economics. Thematic sessions will consist of three to four papers connected by a unifying theme. The individual contributions are expected to be of very high quality, both with respect to the scientific content of the paper and the presentation. Both policy and thematic sessions will be held in hybrid format. However, all papers must be presented by an author who will be present in-person at the conference. ## Post COP27 Workshop

On 13th December 2022, the [UN SDSN Global Climate Hub](#) and [UNFCCC Climate Change Global Innovation Hub](#) hosted the **Post-COP27 Workshop** at the premises of the prestigious [Academy of Athens](#), in Greece.

In this workshop, the UN SDSN Global Climate Hub announced that the 50 internationally renowned scientists affiliated with the Hub will work on developing climate neutrality and climate resilience pathways for Europe, Asia, and Northern Africa, which will be presented during the next UN General Assembly 2023 (September) in New York. Moreover, the European pathways will be presented during the first European Union-wide voluntary review at the UN in July 2023. A big number of politicians, academics, researchers, representatives from international institutions, presented at this hybrid event, which was attended by over 150 participants from all over the world, in person and virtually. ## Prof. Phoebe Koundouri and Benoît Biteau on “How to save the farmers?” on 27 ARTE TV



EAERE President Phoebe Koundouri was invited to participate in the discussion on “How to save the farmers?” together with Benoît Biteau, breeder and member of the European Parliament for Europe Ecologie Les Verts by 27 ARTE TV at their studios in Paris. The two guests embodied two opposing visions of agriculture: Benoît Biteau's vision defends organic farming, the rapid abandonment of dependence on chemical inputs and the end of productivist food policies. On the contrary, Prof. Koundouri, economist and co-chair of the Sustainable Development Solutions Network Europe, mentioned that intensive agriculture and the use of pesticides are solutions to maintain the necessary agricultural production, and the new common agricultural policy is moving in the right direction.

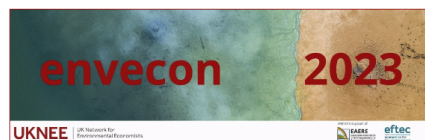

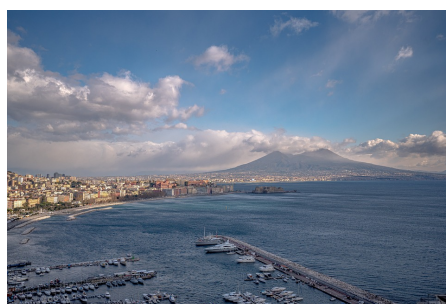

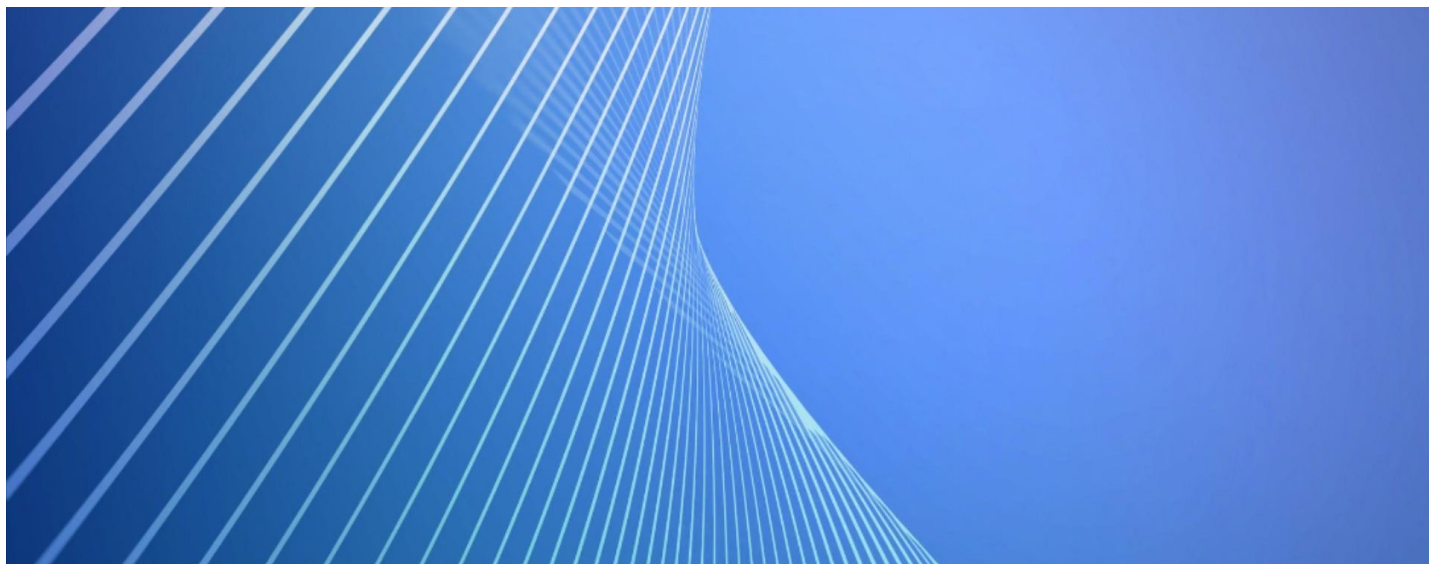

### Copernicus Climate Change Service 2022 Global Climate Highlights

The report summarises the past year's temperatures, greenhouse gas concentrations and significant climate and weather events, show that several temperature records were broken both in Europe and across the world, while other extreme events such as drought and flooding affected large regions.

### EU Carbon Market Report: driving emission reductions and enabling climate and energy investment

The European Commission has adopted its annual [Carbon Market Report](#) which tracks the functioning of the [EU Emissions Trading System \(EU ETS\)](#) from the beginning of the fourth trading phase in 2021 up until to mid-2022. The report finds that ETS emissions from **stationary installations** (energy and carbon-intensive industry) increased in 2021, by 6.6% compared to 2020, but remained below the pre-pandemic 2019 levels.
