



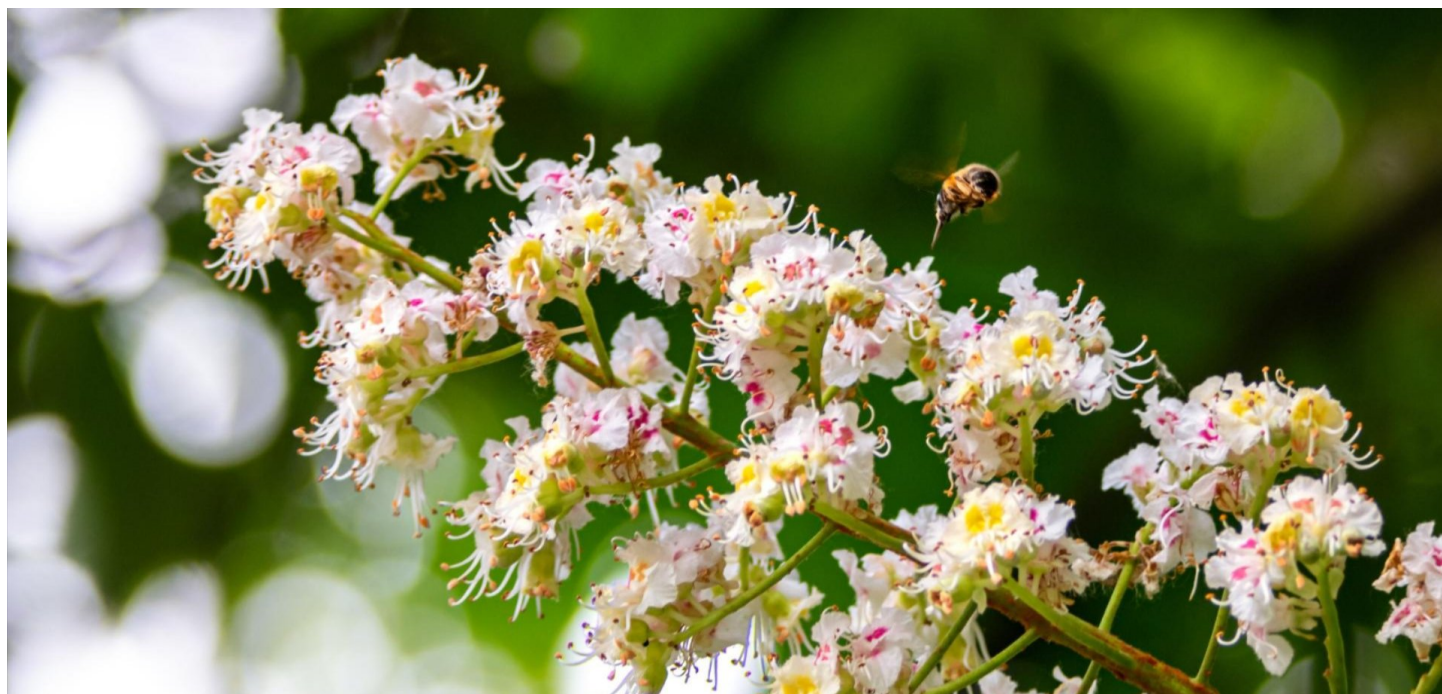

## EAERE Pre-Conference workshop "Governing the Unmanageable – The Political Economy of Global Commons"

This workshop, organized on **26-27 June**, aims to make progress in addressing the importance of (1) political economy realities and barriers to transformation, (2) welfare-theoretic and empirical approaches to inclusive wealth measurement, (3) political economy approaches to international cooperation, e.g. climate cooperation, and (4) recent advances in machine learning to improve policy evaluation and identify high-impact policy interventions that enhance social welfare. 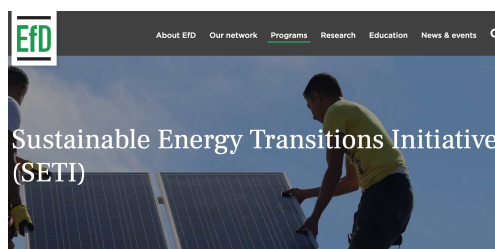

EfD's Annual Meeting is the largest and most vibrant conference in the Global South on the application of environmental and resource economics.

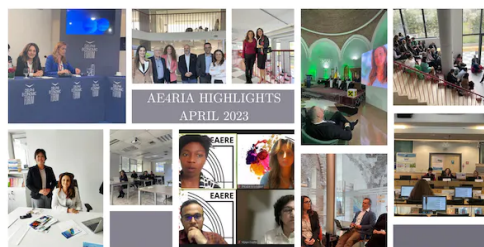

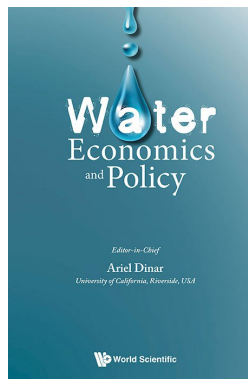

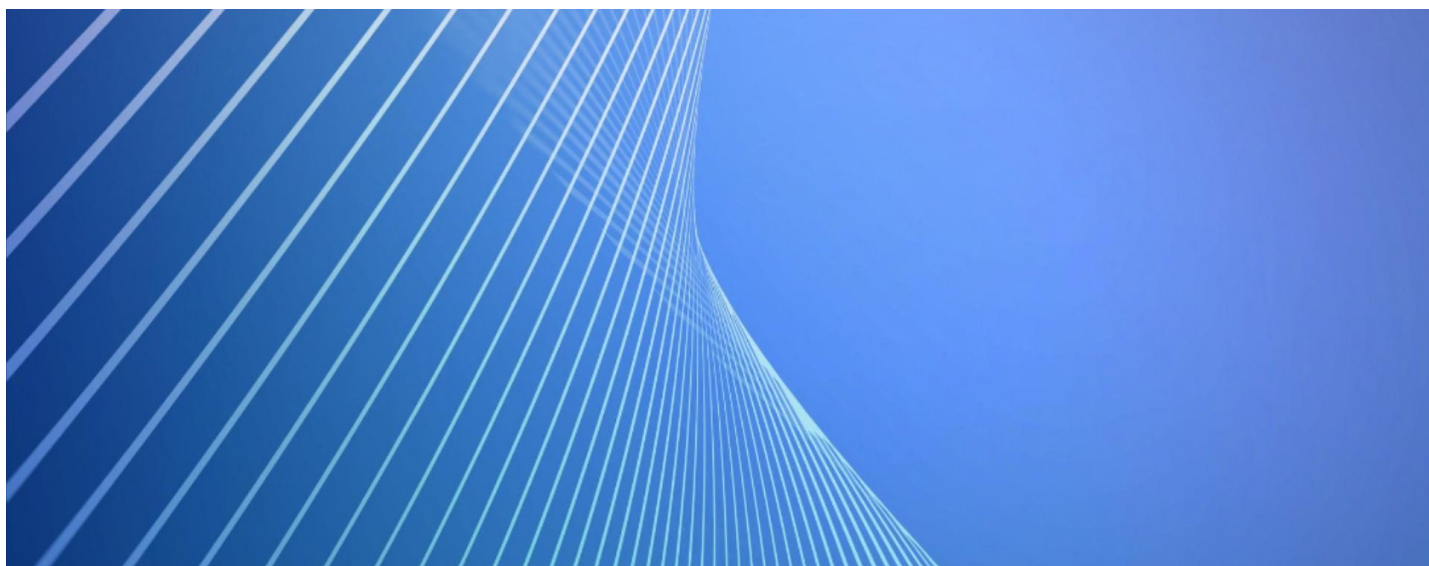

### **Biodiversity Harmful Subsidies at IUCN**

Following the renewed commitment at CBD (UN Convention on Biological Diversity) on BHS (subsidies and incentives damaging biodiversity, ecosystem services and natural capital), the IUCN Swiss Committee (Union Internationale pour la Conservation de la Nature) has organised the conference "Eliminating or transform biodiversity damaging incentives - Where does Switzerland stand in an international comparison, what progress and success factors are there?" at the Natural History Museum in Bern on 11 May 2023.

The Swiss Parliament and Government are advancing in the attempt to eliminate or reform the most damaging BHS. Experts from OECD, France, Germany and Italy, have shared the state of advancement at global and national level for identifying, measuring, eliminate, phase-out or reform BHS.

### **IMF-OECD-WB-WTO launch the Joint Subsidy Platform**

Following discussions and commitments at G7, G20, UN-FCCC and UN-CBD, the heads of the IMF, OECD, World Bank and WTO have announced on 25 May 2023 the launch of a Joint Subsidy Platform (JSP)

at [www.subsidydata.org](http://www.subsidydata.org) to enhance transparency on the use of subsidies. The JSP is intended to facilitate access to information on the nature, size, and economic impact of subsidies, with a view to facilitating dialogue on their appropriate use and design. The initiative should help research, analysis and policies on EHS (Environmentally Harmful Subsidies), including FFS (Fossil Fuel Subsidies) and BHS (Biodiversity Harmful Subsidies).
