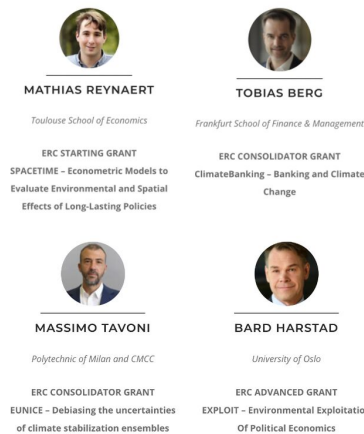

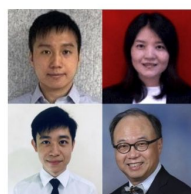

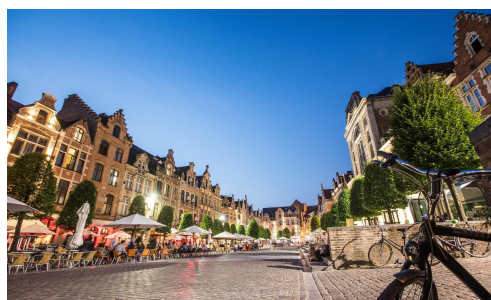
New page on EAERE website dedicated to regional and national Associations



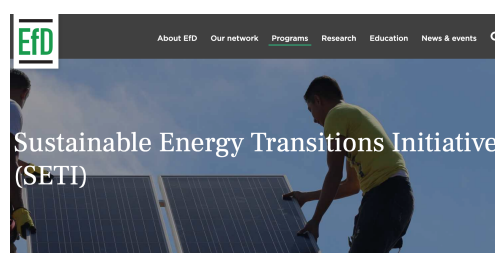
EAERE Pre-Conference workshop "Governing the Unmanageable – The Political Economy of Global Commons"

Researchers from the Potsdam Institute for Climate Impact Research (PIK) in Potsdam, Germany, held the EAERE2023 Pre-Conference workshop “Governing the Unmanageable – The Political Economy of Global Commons” to discuss political economy barriers to management of the global commons. The workshop featured keynotes from Prof. Ottmar Edenhofer (PIK) and Prof. Alexander Lee (University of Rochester) who discussed key challenges to international cooperation in coordinating ambitious climate action. A series of research talks followed with a wide range of experts, addressing the political economy barriers to fossil fuel phaseout, feasibility of climate policy options, welfare theoretical approaches and inclusive wealth measurement, game theoretic approaches to multilateralism, and new machine learning applications for policy analysis. The workshop ended with a panel discussion summarizing the key research themes and charting an agenda for future research efforts. The workshop is organized within the framework of the [FutureLab CERES](#), a research project based at PIK.



EAERE side event: The Sustainable Energy Transitions Initiative (SETI)

On June 27, SETI held a pre-conference workshop prior to the EAERE meeting in Cyprus. The workshop included 8 research papers covering diverse issues related to cooking energy, renewable energy transition, energy efficiency, and electricity quality. These studies collectively considered countries in Latin America, Africa, and Asia. SETI researchers also participated in an elicitation exercise on the expected outcomes from a randomized controlled trial of grants to rural Rwandan households for acquiring appliances, that will be used to help interpret realized outcomes from the study when the experiment is complete. Stay tuned! It was nice for this group to once again gather in person and to provide thoughtful feedback on network researchers' work in progress as well as enjoy one another's camaraderie in this setting. We hope to repeat the experience in future conferences!



An international network on the modelling of climate change and energy policies - GEOCEP side event at EAERE2023

On June 27, the [Global Excellence in Modelling Climate and Energy Policies \(GEOCEP\)](#) organised a side event at EAERE2023 in Limassol. GEOCEP is building an international network of knowledge exchange on climate change modelling and energy policy under the coordination of Charles University. It has organised 57 secondments since February 2022, connecting six European beneficiaries and 16 international partners. Several innovative models have emerged from research and innovation activities, some combining social and natural sciences. The meeting in Limassol drew 55 in-person and online participants, 22 of whom presented a paper at the 2023 EAERE Conference. Participants included representatives from Canada, the Czech Republic, the United Kingdom, France, Italy, South Africa, Switzerland, the United States, and the European Commission's Project

Advisor. GEOCEP has received funding from the European Union's Horizon 2020 research and innovation programme under the Marie Skłodowska-Curie grant agreement No 870245.

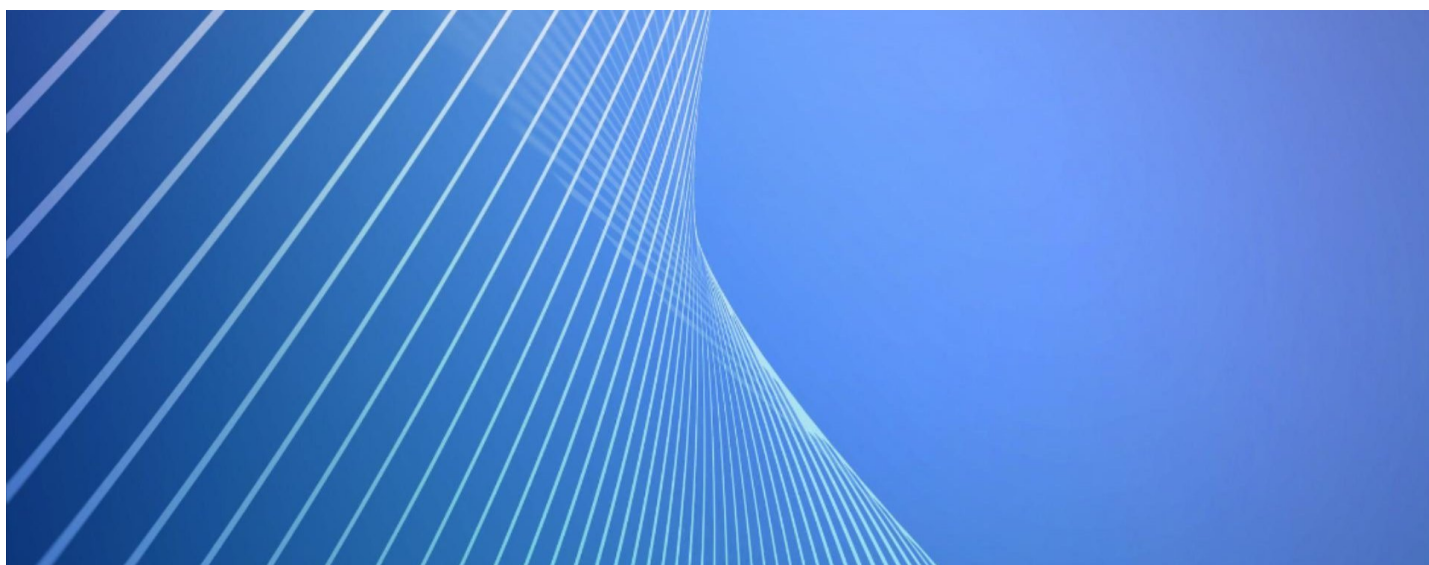

The 5th Italian Catalogue of Subsidies (EHS-FFS-EFS) has been published on the website

Many efforts are ongoing, and sometimes commitments are adopted, at OECD, IMF, WB, UN-FCCC, UN-CBD, G20, G7, EU and in some single countries for removing, phase-out progressively and transform EHS, FFS and BHS in EFS.

The previous Government has cancelled in 2022 5 EHS as a first symbolic step (estimated 0,1 B€); the new Government has confirmed the intention to eliminate - or transform in EFS - all EHS and FFS by 2025.

Prudential and conservative estimates for Italy for 2021 are:

-EHS: 22,4 B€ (Environmentally Harmful Subsidies); of which:

-FFS: 14,5 B€ (Fossil Fuels Subsidies);

-EFS: 18,6 B€ (Environmentally Friendly Subsidies);

-EUS: 11,5 B€ (Environmentally Uncertain Subsidies).

The special chapter on BHS (biodiversity harmful subsidies) has not been repeated.

There is a special chapter on CEHS (Circular Economy Harmful Subsidies) and another on emergency crises' subsidies (Covid-19 , Russian aggression to Ukraine, increase of energy prices) the figures of which are not included in the total estimates because:

a) very variable (from a month/decreed/law to the other)

b) by definition they should be temporary as anti-crisis and emergency driven;
