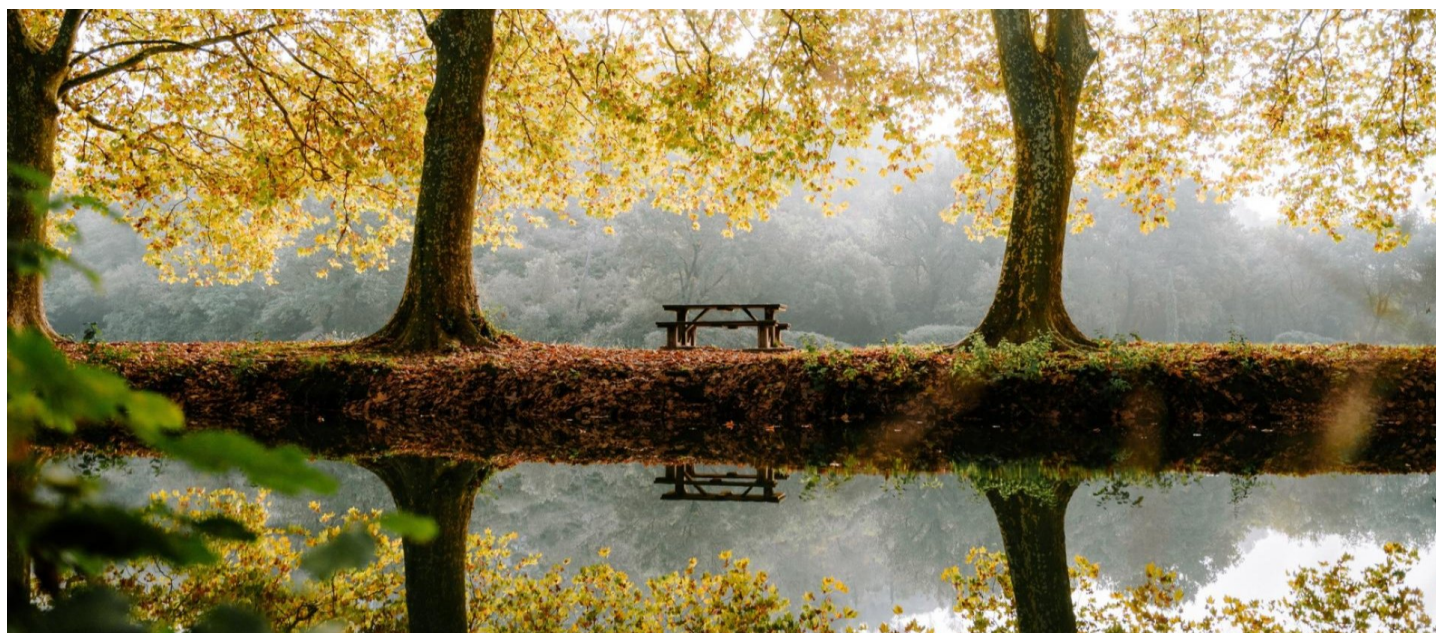

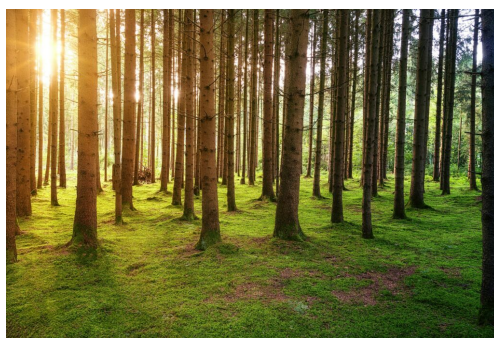
EUI-IAERE School on “Economics and Policy of Trade and Climate Change”

Climate Economics Chair Annual Conference – Policies Toward Carbon Neutrality in Times of Crisis

Understanding how net zero emissions can be achieved in the shortest delays, and coping with crisis and their implications at the same time are questions of paramount importance. This long-term perspective suggests identifying synergies and trade-offs between climate change mitigation and adaptation to crisis, elaborating combinations between short run adjustment and long term actions, and defining public policies and private strategies. An additional concern comes from the economic and financial environment, actually characterized by high inflation and remedies that stress the role of national policies, like the Inflation Reduction Act in the US. This annual edition of the Annual Conference of the Climate Economics Chair, to be held on **October 11-12, 2023**, will shed light on these issues, by gathering researchers in economics, finance and econometrics. Call for Papers 2nd JEEM Conference in Environmental and Resource Economics

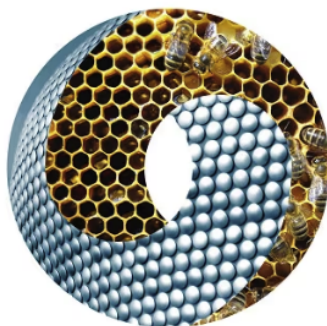

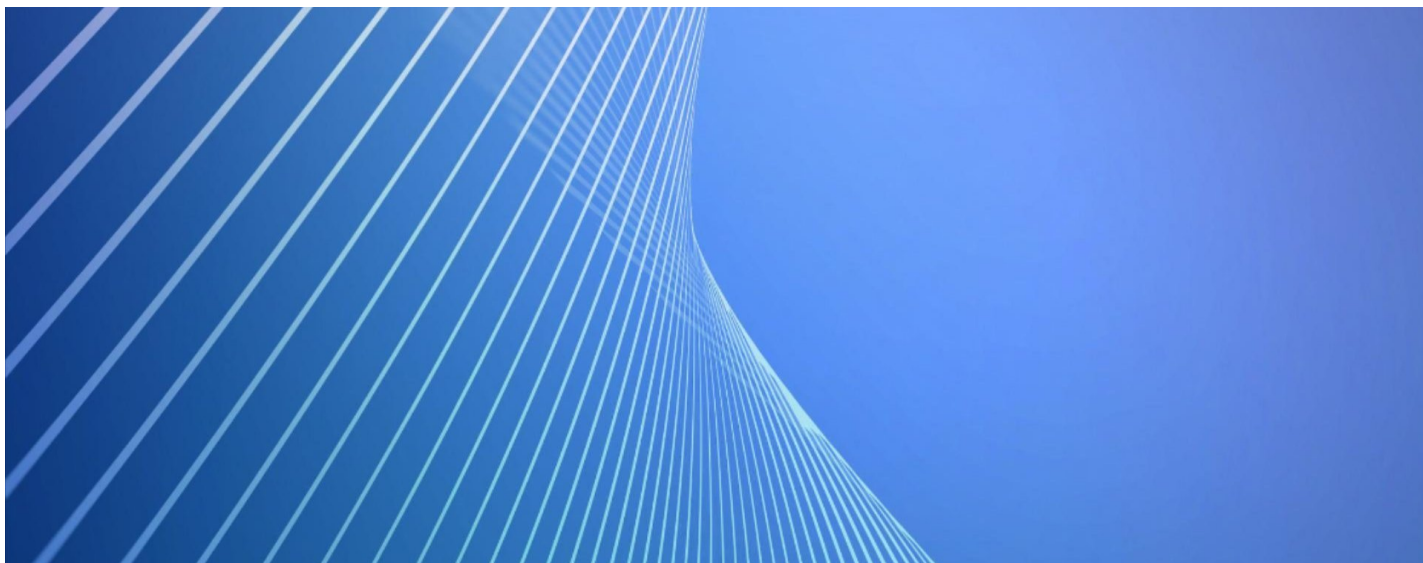


Soil cover of Ukraine in the conditions of hostilities: state, challenges, activities for soil restoration
