SUSEET 2.0 is a Summer School in European Environmental Taxation and policies that will take place from 8th to 13th September 2025 with the support of the **European Union**.

It is a free course where undergraduate students who are achieving their degree in law, economics or political science (master or Ph.D.) will learn the fundamentals of European environmental taxation and policies, become aware of the complex economic and social issues related to this topic.

SUSEET 2.0 has been designed to provide participants with suitable expertise on environmental taxation and policies, useful both for the construction of an academic career and for a professional one, contributing to the creation of a new generation of European environmental tax lawyers and economists. It will provide the occasion for participants from all over the world discuss with eminent professor and experts working in these fields.

LEARNING OBJECTIVES OF THE COURSE

To provide a comprehensive view on economic and legal basis of environmental taxation;

To explore the European constraints to the introduction of fiscal instruments to protect the environment: State Aid rules, freedom of movement, prohibition of discrimination, etc.;

To illustrate the multiple interactions between tax and environment in terms of global policies and their economic and social effects;

To demonstrate the challenges and new opportunities provided by the circular economy;

To analyse energy taxation principles and their concrete application in the framework of the EU energy transition strategy;

To discuss fiscal mechanisms to support a green and inclusive tax reform.
